投稿者须符合以下所有撰稿格式:

- (i) 首页: 注明论文题目,作者中英文姓名(英文姓氏必须大写),服务机关,通讯地址和电邮。
- (ii) 摘要:以另纸附上 200-250 字的中英文摘要,以及 3-4 个关键词。
- (iii) 标题:中文论文标题则依下列格式:

主标题:一、(主题)置中,字型加粗黑。

次标题: (一) (标题) 字型加粗黑,靠左对齐。

小标题(若有必要):(1)(标题)字型加粗黑,斜体字,靠左对齐。

- (iv) 图解: 图解须依数字顺序排列,为方便制作,其格式应限于 125mm x 185mm。 黑白或彩色照片须依"图"为名顺序排列(图1、图2)。图解和照片应附有解 释说明,必要时也应列明资料出处或版权,并置于图之下方。
- (v) 统计表格: 必须依"表"为名顺序排列(表 1、表 2),并把说明置于上方,必要时请在表格下方注明资料出处。度量标准和统计数值应采用公制单位。
- (vi) 引文:参考的资料应在文稿中依(作者著作年份)格式列引。若引用的参考资料有超过三名作者,只须引用首位作者之名及 et al./等。若属同一位作者同一年的著作,如均为名 2000 年的著作,只须以 2000a, 2000b 列明。不同作者但属一个姓氏的英文引文,应以他们的姓以及名字起首字母分别之,如(Ho, P.T. 1965; Ho, P.Y. 1985)。当直接引述原文时须注明页数,如(Zhang 1999: 10)。

若文出自私人谈话,应把以下资料列出,如(何炳郁,写作者谈话,澳洲布里斯班,2000年8月18日)。

- (vii) 注解:解释性的注解应尽量减少,并依先后顺序以阿拉伯数字列在正文,注解应附加在论文末端的"注解"项下。
- (viii) 参考书目: 文稿必须在"参考书目"项下详细注明所有被引用不同语言的参考书目,依作者姓名的首字母依序排列。

NOTES TO CONTRIBUTORS

The *Journal of Malaysian Chinese Studies* is published twice a year, in June and December. It welcomes contributions in Chinese or English. Manuscripts of articles or book reviews should be double-spaced with wide left and right margins and submitted to the following address:

Editor-in-Chief Journal of Malaysian Chinese Studies Centre for Malaysian Chinese Studies No.1, Jalan Maharajalela, 50150 Kuala Lumpur, Malaysia.

Starting from February 2025 (Issue No. 34), manuscripts for articles and book reviews must be submitted in digital format via the Journal of Malaysian Chinese Studies submission website at https://journalmcs.org.my/submit.

Contributors are requested to adhere to the format of the journal as shown below:

- (i) Title page: Indicate the title of the paper, the full names(s) of the author(s) (with the surname/family name capitalized), institutional affiliation, postal and e-mail address.
- (ii) Abstract: Submit an abstract of 200-250 words and 3-4 keywords in a separate sheet in Chinese and English.
- (iii) Headings: Provide clear and concise headings. Not more than three levels of headings should be used:
 - First-level headings centred, initial capitals and bold.
 - Second-level headings flush left, initial capitals and bold.
 - Third-level headings (if necessary) in italics, flush left, initial capitals and bold.
- (iv) Illustrations: Illustrations should be numbered consecutively as figures (Figure 1, Figure 2) and should be reproducible to conform to a format of 125mm x 185mm. Black and white or colour photographs are numbered consecutively as plates. Illustrations and photographs should be accompanied by explanatory captions and, if necessary, a note regarding the source or copyright, and placed below the figure.
- (v) Statistical Tables: These must be typed on separate sheets of paper Tables should beand numbered consecutively (Table 1, Table 2), with its caption placed on top, and acknowledgement of source, if any, at the bottom, of the table. Measurements and statistics should be given in metric units.
- (vi) Citations: References to sources should be cited in the text according to the (Author year) format. To cite a work of reference by three or more authors, quote only the first

name followed by et al. For works of references by the same author for the same year, for example, the year 2000, cite 2000a, 2000b, etc. Citations for different authors with the same surname/family name should be distinguished by using their full names or their initials, e.g. (Ho, P.T. 1965; Ho, P.Y. 1985). Where direct quotations are used, the page number should be indicated, e.g. (Zhang 1999: 10).

Citations based on personal communications should include the following details, e.g. (Ho Peng Yoke, conversation with the author, Brisbane, 18 August 2000).

- (vii) Notes: Explanatory notes should be kept to a minimum, numbered sequentially in Arabic numerals in superscript in the text and the notes appended at the end of the paper as "Notes".
- (viii) References: Manuscripts must provide bibliographic details for all works of reference in different languages that are cited in the text under a section for "References" and arranged alphabetically by author, according to the format as shown below:
